- In 2024, along with partner Fields Alexander and associate Jake McClellan, prevailed in a two-week breach of contract jury trial. Beck Redden brought suit alleging that the termination had been wrongful, and seeking the recovery of the profits its client would have earned over the life of the contract. The jury sided with Beck Redden on all issues, awarding over \$15,000,000 in lost profits. With interest and attorneys' fees, the judgment in favor of Beck Redden's client exceeds \$26,000,000.
