## United States Court of Appeals for the Fifth Circuit

- *Southwest Airlines Co. v. Liberty Insurance Underwriters, Inc.*, 90 F.4th 847 (5th Cir. 2024)  
Assisted in securing a reversal of a summary judgment order in a cutting-edge insurance coverage dispute regarding a business interruption policy. Beck Redden's client, Southwest Airlines, was able to continue with its claim for coverage as a result of the reversal.
