

# Beck Redden 1L Diversity Fellowship

Application materials due by February 11, 2022

As part of Beck Redden's ongoing commitment to diversity, equity, and inclusion, we are proud to offer a 1L Diversity Fellowship to outstanding first year law students. Fellows will receive a paid 1L Summer Associate position (minimum six-week commitment; compensation commensurate with first-year associate) and an award of up to \$30,000 to assist with law school tuition. The award will be paid in three installments: \$10,000 upon acceptance of the Fellowship; \$10,000 upon receiving and accepting an offer to return for a minimum of six weeks following the Fellow's 2L year, and \$10,000 upon receiving and accepting an offer to join the firm as a full-time associate upon graduation or following a judicial clerkship.

The eligibility, selection criteria, and application process for the program are as follows:

## Eligibility

This is a merit-based fellowship. Fellowship applicants must meet the following criteria:

- Enrolled full-time in an ABA-accredited law school with an anticipated graduation date of 2024 at the time of application;
- Minimum six-week commitment to Beck Redden's 2022 summer associate program;
- A U.S. citizen or otherwise authorized to work in the United States; and
- Will not be the recipient of a diversity award from another law firm paid between January 1, 2022 and August 31, 2022.

## Selection Criteria

Fellows will be selected based on consideration of the following factors:

- Academic and leadership achievements;
  - Obstacles, challenges, or other factors encountered in advancing career objectives;
  - Oral and written communication skills;
  - A desire to excel in trial or appellate practice;
  - Demonstrated interest in joining Beck Redden; and
  - Ability to advance the firm's diversity & inclusion initiatives.

## Application Process

To be considered for the Beck Redden 1L Diversity Fellowship, candidates must provide the following documents to Addison L. Braun at [abraun@beckredde.com](mailto:abraun@beckredde.com):

- Completed application form;
- Current resume;
- Unofficial or official undergraduate and law school transcripts; and
- A brief statement (500 words or less) discussing your background and what life experiences you have had that demonstrate your ability to persevere, and how your unique experiences will contribute to the practice of law.

A legal writing sample and letters of recommendation are optional but appreciated.

## Timeline

Beck Redden will not consider applications received after February 11, 2022. A selection panel will evaluate completed applications, conduct interviews, and announce Fellowship recipients on a rolling basis. Because of the highly selective nature of the 1L Diversity Fellowship and the limited number of Fellowships available, students are encouraged to submit applications at their earliest convenience.
