

Beck Redden 1L Diversity Fellowship

Application materials due by February 3, 2023

As part of Beck Redden's ongoing commitment to diversity, equity, and inclusion, we are proud to offer a 1L Diversity Fellowship to outstanding first-year law students. Fellows will receive a paid 1L Summer Associate position (six-week program; compensation commensurate with prevailing scale of first-year associate) and an award of up to \$30,000 to assist with law school tuition. The award will be paid in three installments: \$10,000 upon acceptance of the Fellowship; \$10,000 upon receiving and accepting an offer to return for six weeks following the Fellow's 2L year, and \$10,000 upon receiving and accepting an offer to join the Firm as a full-time associate upon graduation or following a judicial clerkship.

The eligibility, selection criteria, and application process for the program are as follows:

Eligibility

This is a merit-based fellowship. Fellowship applicants must meet the following criteria:

- Enrolled full-time in an ABA-accredited law school with an anticipated graduation date of 2025 at the time of application;
- Six-week, first-half only commitment to Beck Redden's 2023 summer associate program; and
- A U.S. citizen or otherwise authorized to work in the United States.

Selection Criteria

Fellows will be selected based on consideration of the following factors:

- Academic and leadership achievements;
- Oral and written communication skills;
- A desire to excel in trial or appellate practice;
- Plans to practice in Houston, Texas after graduation; and
- Demonstrated interest in joining Beck Redden.



Application Process

To be considered for the Beck Redden 1L Diversity Fellowship, candidates must provide the following documents to Cecy Garcia at cgarcia@beckredden.com:

- Completed application form;
- Current resume;
- Unofficial or official undergraduate AND law school transcripts (must include first semester law school grades);
- A brief statement (150 words or less) discussing your interest in litigation and practicing in Houston, Texas; and
- A brief statement (500 words or less) discussing your background and what life experiences you have had that demonstrate any of the following: your ability to persevere, your commitment to promoting diversity or cultural exchange, and/or how your unique experiences will contribute to the practice of law.

A legal writing sample and letters of recommendation are optional but appreciated.

Timeline

Beck Redden will not consider applications received after February 3, 2023. A selection panel will evaluate completed applications, conduct interviews, and announce Fellowship recipients on a rolling basis. Because of the highly selective nature of the 1L Diversity Fellowship and the limited number of Fellowships available, students are encouraged to submit applications at their earliest convenience.
